## READ BEFORE USING GOLF CART: Golf Cart Rental Information Sheet

## **South Carolina Golf Cart Laws:**

- 1. RESTRICTED ROADS: Highway 17, 27th Ave South, Sea Mountain Hwy, Ocean Blvd. South of Sea Mountain Hwy
- 2. Golf Carts are ONLY ALLOWED ON SECONDARY ROADS, with posted speed limit of 35 mph or less. Golf Carts can cross Highway 17 at the stop lights, but are NOT ALLOWED ON HIGHWAY 17.
- 3. Golf Carts should pull over to allow vehicles to pass if you are slowing traffic down
- 4. DO NOT OPERATE CART ON THE BEACH
- 5. DO NOT OPERATE ON SIDEWALKS
- 6. ONLY ALLOWED TO DRIVE DURING DAYLIGHT HOURS
- 7. ONLY PERSONS 21 years of age and older, possessing a valid driver's license are allowed to rent the golf cart. Must be 21 years old and possess a valid driver's license to drive the golf cart.
- 8. Parents or Guardians allowing an unlicensed child to operate golf carts are subject to a fine in excess of \$200.
- 9. Golf Carts being operated in violation of state law are subject to being towed at the Renter's Expense
- 10. Use Hand signals for Signaling while driving the Golf Cart to allow cars to understand the direction you are turning Arm Bent up= Turn Right Arm Straight Out = Turn Left
- 11. DO NOT EXCEED SEAT CAPACITY ON CART Including Children
  - 4 (Basic cart)= 4 People
  - 6 (Limo Cart)t= 6 People

## Salty Frye's Golf Cart Rental INFORMATION:

- 12. You are responsible for the lock and keys during your rental.
- 13. Lost Keys are \$25 to replace
- 14. Lock replacements are \$30.00
- 15. Renters are responsible for any parking ticket you receive while in possession of the golf cart. Any towing expense will be the responsibility of the renter and any one in their party.
- 16. NO RECKLESS DRIVING ALLOWED. These are personal transportation vehicles. They are designed for regular driving. NO WHEELIES, Jumping on back foot Board, Donuts, or off road driving.
- 17. DO NOT MAKE TURNS at a HIGH SPEED
- 18. Our Golf Carts are inspected for damage at the point of delivery or pickup. In the Event the Golf Cart is damaged during the rental period, the repair cost will be charged to your credit card.
- 19. It is our goal to provide customers with a reliable gas golf cart by which we perform routine maintenance and test. This is to ensure you get the most use out of the cart during the rental. In the event a problem does arise we ask that you first check all operating instructions are being followed. DO NOT FOR ANY REASON ATTEMPT TO PERFORM MAINTENANCE or REPAIRS on the Golf Cart. Should the problem result be sustained and there is a loss of use during the agreed rental time, you will be refunded appropriately. Failure to notify us of a problem will result in NO REFUND for the period of time we were not notified of the problem.
- 20. In the event your golf cart has any problems, PLEASE CALL 843-999-1703. We will make a service call to evaluate the problem.
- 21. If it is determined the problem is a result of improper operation of the cart a \$75.00 fee will be charged to your credit card.
- 22. Salty Frye's Golf Carts reserve the right to revoke the use of the Golf Cart without a refund for any reason.
- 23. Salty Frye's Golf Carts does not provide insurance for your Golf Cart. You, your guest and any third party are solely responsible for the entire cost, or any repairs sustained to the golf cart during your rental period. If you do not notify Salty Frye's Golf Carts of any damage prior to taking possession of the golf cart you are responsible for all or any cost.
- 24. Please fill the gas tank up before returning the cart. There will be a \$10.00 convenience fee for unfilled tanks.
